Over the past decade, States have increasingly sought to insulate regulatory prerogatives to ensure domestic environmental protection, away from their parallel international obligations to guarantee continuous foreign market access and investment protection. While both the international trade and investment regimes contain 'safety valve' provisions to protect States' policy spaces (especially to ensure environmental protection), the results are varied from the trend of international adjudication at the World Trade international investment Organization and arbitrations (whether by tribunals formed under the International Centre for Settlement of Investments Disputes/ICSID or non-ICSID arbitral tribunals).
